General damages is an award of compensation that is based on the injury or injuries you have suffered. It will vary depending on the type of injury, how long the injury lasts and whether it has any ongoing or long-term impact. A person suffering from minor head injury and no injury to the brain, may be entitled to claim compensation in the region of about £3,000 to £6,000.
