Renew an Agent License You are required to renew your license annually or biannually, depending on when it was first issued. Licensees who miss the renewal deadline may file a late renewal request, which includes a \$15 late fee in addition to the renewal fee, within 15 days of the license expiration date. < Back to Agent Licensing & Renewals

If you have a Georgia Property and Casualty Insurance License, you will need to take 24 hours of insurance CE. Amendments: Example - If an agent holds a Life license and they are now applying to add property, the fee is \$120.00 for the license and \$20.00 for the processing fee for a total of \$140.00. Fee examples: Agent nonresident life: \$120.00; Agent nonresident life, accident & sickness: \$120.00; Agent nonresident life, property: \$220.00

You must also hold or apply for a property and casualty agent license. You must achieve a passing score on Surplus Lines Broker examination. For information regarding examination procedures, visit the Pearson VUE website. You can apply via NIPR or Sircon. Complete a \$50,000 surplus lines broker bond. Pay the \$615 fee.

This course is approved by the Georgia Insurance Commissioner Office as a Pre-licensing Course for individuals who want to obtain a license to become a Agent in the state of Georgia. This course is a prerequisite to taking the state exam.

Licensing Class for Insurance Agents and Adjusters

Georgia Property and Casualty agents/producers are required to take an approved 40-hour Property and Casualty course and pass the Pearson VUE 12-GA-06 licensing exam. Georgia Property and Casualty Sub-Agents are required to take an approved 20 -hour Property and Casualty course and do not have to pass a licensing exam, just apply under an existing agent.

Georgia Insurance - Pearson Vue

In Georgia, insurance licenses expire every two years. The expiration will be on the last day of your birth month, biennially, based on the anniversary of your original license year. This means that if you were licensed on an even-numbered year, your license will expire on the last day of your birth month in the next even-numbered year.

Average Cost of Property and Casualty License The property and casualty license cost for individual insurance brokers and agents ranges from \$0 to \$300, depending on which state you are doing your business. The following are the complete list of the P&C license fees per state that are valid for two years:

How Much Does Property And Casualty License Cost In 2020?

General Requirements Georgia Major Lines Licensed Agents must complete 24 Credit Hours of Approved Continuing Education every 2 years to be eligible to Renew their License. At least 3 of the 24 credit hours must be approved for Ethics Training.
